Today i.e. 18/05/2025 at 11:55 pm, received an information that on the same day at around 11:20 pm, a large number of people including male and women folk numbering about 500/600 of Part-II Devi Mandop Leikai were assembled at Heirok Part-II Thokchom Bazar and organized unruly mob by holding deadly weapons like daos, stick, stones etc. and storm at the house of Ningthoujam Rajnikanta Singh and his relatives. Further, they dismantled the house of Ningthoujam Rajnikanta Singh, Ningthoujam Leihao Devi and Mr. Jiten Singh of Heirok Part-II Mayai Leikai in c/w death of Laishram Tombi Singh 45 years S/o (L) L. Khomei Singh of Heirok Part-II Devi Mandop Leikai. On receipt of the information, self along with police teams rushed to spot and dispersed the mob. As a result of which of 3 (three) houses and 1 (one) outhouse were badly damaged and some household items were also damaged. The monetary value of damaged properties is may be about Rs. 700000/- (Seven lakhs only).

In c/w this incident which led to the demise of Laishram Tombi Singh 51 years S/o (L) L. Khomei Singh of Heirok Part-II Devi Mandop Leikai, further information was received that a farm house located at Heirok Part-II Khangarok in r/o Ningthoujam Rajnikanta Singh 44 years S/o Late N. Mengjor Singh of Heirok Part-II Mayai Leikai was partly damaged and set ablaze by unruly mob. On receipt of this information, self along with police teams rushed to spot and controlled the fire. The monetary value of damaged property is may be about Rs. 150000/- (One Lakh fifty thousand) only.


