The examination statement was recorded on a sheet of paper. In his examination statement, he stated that on 19/7/2024 one Yengkhom Premchandra Singh @ Prem Meitei S/O Y. Ratan Singh along with Moirangthem Danny Singh and Thokchom Kelish Singh, all are resident of Kakching Sumak Leikai, P.S Kakching had come to his residence and they brought a swift desire car being Regd. No. MNO1AW 4333 and requested him to lend then a sum of Rs. 3,50,000/- (Three Lakh Fifty Thousand) only for some months and in turn they ask him to keep the said vehicle as surety till repayment of the said amount with interest. He had known the said three persons before the said day. Then on 08/11/2024 Yengkhom Premchandra Singh @ Prem Meitei came to his residence along with another person who is said to be the real owner of the car and requested him to allow the said person taking the said car or they all would face police case. On that day the said Yengkhom Premchandra Singh @ Prem Meitei had



executed a hand assurance that he would give another car of the same value of the Swift Desire Car within February 2025. Believing his assurance, He had handed over the said car to the person who was claiming to be the real owner of the said car. Another assurance was also executed by the said Yengkhom Premchandra Singh @ Prem Meitei that an amount of Rs. 3,50,000/- (Three Lakh Fifty Thousand) only would be repaid to him within 5<sup>th</sup> of February, 2025 at 11 a. m.

In that, the said three persons have been hiding from him and also avoided his calls and meetings with him, moreover they failed to repay his above mention amount or any vehicle as promised by the said Yengkhom Premchandra Singh @ Prem Meitei till date.

Further, a Wireless Msg no. 16/HRK-PS/2025/2234, dated:8/6/2025 was forwarded to OC/KCG-PS requesting the appearance of the above-mentioned individuals on or before 10/6/2025 at 2:00 pm. However, the three individuals failed to appear at HRK-PS within the stipulated time.


