First Information contents:

One Mr. AS Chinaongam of Tushar village presently residing at Hamleikhong A-Block, Hungpung, Ukhrul district Manipur reported to this PS stating that his son Mr. **AS Thotshang** (45 yrs) S/o AS Chinaongam of Tushar village A/P Hamleikhong A-Block, Hungpung and Mr. Md Abij Uddin, mechanic of Mona workshop, Awungtang, Hungpung village, Ukhrul along with one vehicle Regd. No. MN03P5052 has been missing since yesterday and the family members do not know where are they and still missing yet to return at house. Therefore, the family request the concerned authority to trace the missing person and vehicle where about. Hence for enquiry.

On 22/05/2025 at 08:30, OC/UKL-PS team went to the Mona Workshop at Awungtang, Hungpung village, Ukhrul for enquiry. The rented room of Abij Uddin, mechanic of Mona workshop was found under lock and key. The police team in the presence of Mona, owner of the workshop lock opened the door and found one dead body covered with a blanket with blood stains on the floor. The dead body was identified to be AS Thotshang (45 yrs) s/o AS Chinaongam of Tushar village, Ukhrul by relative of the deceased. One alto K10 car bearing Registration No. **MN03P/5052**, white in colour belonging to the deceased was found missing. It is thus ascertained that Abiz Uddin, the mechanic of Mona workshop after committing the murder and hidden the dead body in his room hijacked the said car and vanished away.

Hence the complaint case under GD entry No. 14/UKL-PS/2025 dated 21/05/2025 is converted to regular **FIR No. 02(05)2025/UKL-PS U/s 103(1)/307 BNS.**
