Today i.e. 07/6/2025 at 8:40 pm, received information that on the same day i.e. 07/06/2025 at around 8:10 pm, a mob numbering about 200 persons including womenfolk stormed into the house of one Md. Ziyaoddin (aged about 60 yrs) S/o Md. Chaoba @ Khongsang of Keirao Makting Mayai Leikai by holding sticks and deadly weapons. The unruly mob vandalized the house of Md. Ziyaoddin and property inside it. Moreover, the mob also burnt down 2 nos. two wheeler vehicles on the spot.

Hence, a case under FIR No. 49(6)2025 IBG-PS U/S 191(2)/191(3)/329(1)/324(4)/326(f) BNS, 2023 has been registered on suo motto for investigation.
