I am to inform you regarding illegal excavation and transportation of Hill Earth from Laipharok Maring Village area inside the Nongmaiching Reserved Forest by some unknown miscreants. It may be mentioned that

1. The excavation site lies within **compartment No. 26, Iril Block of Nongmaiching Reserved Forest.**
2. Illegal excavation of Hill Earth from Reserved Forest area violates **section 26 of Indian Forest Act, 1927.**
3. The excavation work was done on **13th June 2025 and 14th June 2025** during day time as well as during Midnight, and due to shortage of manpower and the forest staff and officials being unarmed, the Forest staff and officials are finding it very difficult to either stop or nabbed these unknown miscreants.

It is, therefore, to request you to lodge an FIR against unknown persons for destruction of public property in the interest of the public and the state as a whole.
