I am writing to formally report a theft that occurred at my newly under-construction building located at Kyamkei, Imphal East, where the bomb was fitted in the handle of the gate on 28th March 2025 by the underground KCP-PWG for demanding a huge amount from me, I have already submitted a complaint to the Police Station at the same day. After the accident, I could not go to the site for many days. The incident is believed to have occurred sometime from April to May 2025, as it was discovered after a routine inspection.

Upon assessment, it was found that several furniture items (enclosed) and electrical fittings/appliances (enclosed) were stolen from the premises. The items missing include, but may not be limited to:

- · List of major items stolen, e.g., light fixtures, switches, furniture pieces (photograph)
- · Any evidence of forced entry or other relevant detail

I suspect the theft occurred at night or on days when there was no activity at the site. This has resulted in considerable financial loss and delayed further occupancy preparations.

I kindly request your office to investigate this matter thoroughly and take necessary action. If needed, I am prepared to provide all required documents, including the construction item purchase receipts and photographs.

Please treat this as an urgent matter. I would also appreciate an official FIR (First Information Report) filed about this complaint.
