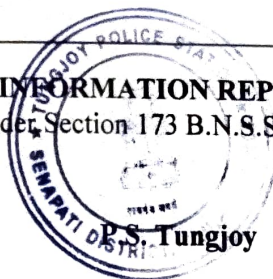

Subject: Filing of FIR regarding willful destruction of stone crusher 84 KV Kirloskar generator unit worth Rs. 10 lakhs by unknown miscreants under relevant provisions of BNS, 2023.

Sir,

I, the undersigned, **S. Machingaolou Ruh, S/o H. Solomon**, resident of Laii village humbly lodge the following report for your kind perusal and necessary legal action:

That, I am the lawful owner/authorized representative of the **Rapaobuh** stone crusher Kirloskar generator, having ownership/operational control over a stone crusher unit located at **Rapaobuh**. That on the night of 14th June, 2025 at or about 2:00AM, certain unknown persons, with the intent to cause wrongful loss and destruction, unlawfully trespassed into the premises of the said stone crusher unit and maliciously set fire to the Kirloskar generator machinery, control room and stockpile thereby destroying essential property and causing severe economic damage.

That the aforesaid criminal act is cognizable and punishable under the following provisions of the **Bharatiya Nyaya Sanhita, 2023(BNS)**:

Section 326(F) BNS – Mischief by fire or explosive substance, intending to cause damage to property.

Section 326(G) BNS – Punishment for mischief by fire or explosive substance(destruction of property).

Section 61 BNS – Criminal conspiracy (as this was a well – orchestrated attack).

Section 3(5) BNS – Acts done by several persons in furtherance of common intention.

Section 324(5) BNS – Mischief causing damage to the amount of one lakh rupees upwards.

Section 329 BNS – Criminal trespass.

Section 330 BNS – House trespass and house breaking.

That this criminal act not only amounts to mischief and arson but also poses a grave threat to public safety and order in the locality, potentially disturbing peace and creating fear among other industrial operators and residents.

Relief Sought:

That I request your good office to immediately register this report as an FIR, conduct a thorough investigation as per the aforesaid sections of BNS, immediate visit by police officials to inspect the scene and collect evidence,

Deployment of police protection if threats persist,

Identification and arrest of culprits at the earliest, and

Assessment of damages and preservation of remains as evidence.
