I have the honour to report that, today i.e 16<sup>th</sup> June 2025 at around 8:30 pm while Joint Mobile team comprising of District Police, 1<sup>st</sup> IRB and B/157 CRPF under the supervision of Inspt. Jangkohao Haokip, OC/HLP-PS were conducting routine frisking and checking at FCI Godown, Tualnuam Village, Churachandpur one individual driving un-registered Honda Activa (Navy blue colour) moving towards Churachandpur town in a suspicious manner was stopped and on proper checking, 7(seven) plastic container containing suspected opium were found from the possession of the individual which was concealed inside one carry bag (blue colour). The individual was identified as Mr.Mangminlian Suantak (20) years s/o S. Hangkhanlal of Suanguang Village, Singngat Sub-division, Churachandpur A/P V.Munhoih, New Lamka, Churachandpur. Immediate information was given to Police Control Room/CCPur and a requisition was made to District Magistrate, Churachandpur for deputing one Executive Magistrate. Accordingly one Executive Magistrate namely Shri. Lianminthang Samte, SDC/EM Churachandpur was deputed at the spot.
