With due respect and regard, I wish to report that today, i.e., 02/06/2025, at about 5:20 PM, I, along with my wife, Mrs. Ruhima Khulakpam, was at Yairipok Bazar New Market to purchase some household items. I had parked my Honda Activa 6G DLX-BSVI (Blue), bearing Registration No. MN06SE 7743, Engine No. JF91EG1598357, and Chassis No. ME4JF914HMG599640, in front of the New Market under proper lock and key.

After a short while, one unknown person was caught red-handed by members of the public present at Yairipok Bazar while attempting to steal my Honda Activa with a T-shaped metal tool. The individual was later identified as Md. Abas Khan (28 yrs.) S/o Md. Nizamuddin of Lilong Mairenkul ITI Road.
