First Information contents:

Today i.e 08/06/2025 at 05:15 pm a large mob estimated to be around 400-500 people comprising both males and females attempted to forcibly enter the Yairipok Police Station. The mob's actions were in clear violation of the public curfew order passed by the District Magistrate, Thoubal vide order No. 4/65/DC(TBL)/2009/L&O/2024 dated 07/06/2025. The situation escalated rapidly as the mob used deadly weapons such as sticks, stones and iron rods to try and breach the police station. In order to prevent the unruly mob and prevent any harm to the Police Station and personnel belonging to SDPO/YPK, Yairipok PS, Commandos team & G-Coy, 152 Bn. BSF stationed at Yairipok PS, Anti-riot equipments like Mob Bomb, Tear Gas etc. were expended to disperse the crowd and restore order in the area. The situation was eventually brought under control and mob was dispersed at around 5:30 pm of 08/06/2025.

Hence, a sou motto case under FIR No. 21(06)2025 YPK-PS u/s 190/191(2)(3)/223(a)(b) BNS, 2023 is registered for investigation.
