Sub :- Lodging of FIR against unknown miscreants for firing on Govt vehicle, stone pelting, damage to Govt. vehicle and injury to 04 BSF personnel and 01 civil driver while enroute to PS Yaripok for reinforcement on 08th June 2025 at about 1145 Hrs.

It is to inform that on 08/06/2025 at about 2230 hrs, A joint QRTs team (THQ, D/111 & B/171 BN BSF) led by Sh. Narendar Kumar Commandant/2IC, Sh. Krishan Kumar DC/Adjt, Inspr Rabi Narayan Swain Offg Coy Comdr of D Coy Ex-111 BN BSF a/w 04 SOs and 16 Ors Total-21 pers Adhoc of M&C XVI BN BSF left for re-inforcement to G/152 BN BSF at Yairipok PS where mob was attacking and pelting stones including petrol Bombs at Jawans/BSF camp G/152 (PS Yairipok). While enroute to PS Yairipok, at about 082345 hrs miscreants approx. 1700 were assembled on both side of the PS and tried to stop the QRT vehicles forcefully, the pelted stones and 01 round of gunshot was also fired which hit the driver side of the civil vehicle Scorpio Regt No MN 01 S 1073 driven by Sh Rojen Singh who sustained vehicle glass splinter injury on his face, they hit the vehicles with bamboo sticks therefore, troops immediately retaliated in self defence and for dispersing the mob, during retaliation 05 rounds of 9 MM ball of SMG fired in the Safe direction in air to disperse the mob by No. <u>041041453</u> Inspr Rabi Narayan Swain bearing SMG Butt No. 44 Body No. 11/13652, Lot No. catrg 9 mm Ball Lot-091 KF-2021 and 01 chilly hand grenade was also fired by No. 045444696 CT Mahendra Chetry bearing Lot No. 44 there after the mob disperse.

In scuffle with mob/miscreants damaged the Govt Vehicle AS 11 FC 0287 TATA 407 wind class cracked, torn tarpaulin, Bolero Neo AS 11 AA 5337 got damaged dented a/w rear and side door glass broken. Two civil vehicle bearing No. MN 01 AS 1073 Scorpio frontal wind screen rear glass and right door glass broken. Another MN 01 AK 6436 Bolero Neo- wind shield both broken by mob/miscreants

nearby Yairipok market area. By throwing stones vehicle got dented all around.

After open fire in air, mob dispersed and Quick reaction team (QRT) reached Yairipok PS to re-enforce to the BSF Coy at about 082350 hrs.

In self defence 04 rounds of 9 MM SMG were fired. However only 01 empty case was recovered due to

darkness/market area in the volatile situations.

The miscreants/Mob constantly pelted stones on the Govt /Civil Vehicles and damaged them which were engaged. In execution of Govt bonafide duty as to re-enforce the BSF troops of G/152 Coy.

In scuffle with miscreants, they had fired on vehicles and pelted stones resulted minor injury inflicted to BSF Pers which is superficial in nature. Their details are given below

Therefore, it is requested to register a FIR against Mob/ unknown Miscreants of Yairipok those have damaged Govt/Civil vehicles and forcefully tried to stop Govt official from performing Bonafide Govt Duty.
