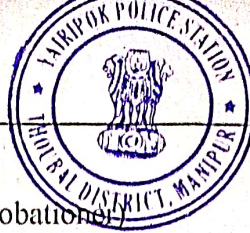

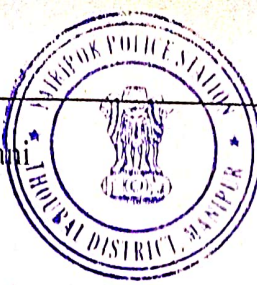

A large mob estimated around 200-300 unknown persons suddenly attacked to Yairipok PS from different directions starting from 11:00 pm of 08/06/2025 by pelting stones, firing tear gas shells and live rounds with an intention to kill the Police personnel and central forces camped at Yairipok PS by violating the public curfew order passed by the District Magistrate, Thoubal vide order No. 4/65/DC(TBL)/2009/L&O/2024 dated 07/06/2025 thereby causing damaged to the vehicles parked inside the PS campus. The police teams including CDOs and G-Coy, 152 Bn. BSF personnel stationed at Yairipok PS defended by expending tear gas shells however, the mob became wild and at last dispersed and controled the situation by firing some live rounds in the sky under the supervision of SDPO/Yairipok at 2:30 am of 09/06/2025.

Hence, a sou motto case under FIR No. 23(06)2025 YPK-PS u/s 191/109/132/223/324(6) BNS, 2023 & 25(1-C) A. Act is registered for investigation.
