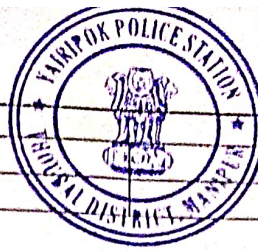

Sir,

It is to inform that on dated 08/06/2025 at about 1700 hrs appx 700 ladies and approx 1300 men of Meira Paibis and Arambai Tenggol organizations started gathering on the Yairipok Penchi road in front of Yairipok police station, distt - thoubal CBI and the SDPO and OC Yairipok PS were trying to pacify them and even made announcements on the loudhailer, but the crowd turned violent and started attacking and ransacking the front gate of the police station, then on the orders of Coy Cdr Sh Vikrant Singh, AC and SDPO, At about 1710 hrs, our QRT party responded swiftly and fired non-lethal ammunitions like tear smoke shell, stun grenade and tear smoke grenade to disperse the crowd and the crowd started dispersing and ran away. Then again at 2045 hrs in order to provide a safe passage for the QRT to get inside police station Yairipok, 02 Rds of illu and live Rds were fired keeping a safe angle in the air and the mob also broke the street lights and taking advantage of the darkness started hurling Molotoy cocktail on rifle morcha no 1 and rifle morcha no 4, in order to illuminate the area 02 illu bombs were fired by 51 mm mortar butt no 19 and followed by tear smoke shells in the direction of mob and live rounds were also fire keeping a safe angle in the air.
