First Information contents:

On 25/03/2024 at 5:10pm, Inspt. Chuingam Ningshen, OC UKL PS received a reliable information that one unknown person was found lying death near Hongva on NH-202 (between Ukhrul & Langdang), 6km (North-East) away from Ukhrul PS. Later, on reaching the spot, the relatives of the deceased person identified the death body as Bishal Karki, 38 years, S/o Late Nal Bahadur of Khatkati, Phurbati, Karbi Anglong District, Assam, presently residing at Cement Factory, Hungpung Village, Ukhrul District, Manipur. Hence a UD Case No.01/UKL-PS/2024 U/S 174 Cr.PC was registered for enquiry.

The enquiry was conducted by S.I Ngashanhao Sareo of Ukhrul Police Station, whosubmitted with the following facts and findings that have emerged during the course of enquiry, which strongly suggest that the death was not natural or accidental, but suspicious and likely homicidal in nature.

1. Background of the case:

- i) The dead body of a male person was recovered on 25/03/2024 at 05:10 pm near Hongva on NH-202 (between Ukhrul and Langdang), about 6 km N/East.
- ii) A case of unnatural death was registered and enquiry was taken up under section 174 CrPC.
- iii) The deceased was later identified as Bishal Karki (38 yrs) S/o Late Nal Bahadur of Khatkati, Phurbati, Karbi Anglong District, Assam, A/P- Cement Factory, Hungpung Village, Ukhrul District, Manipur. A taxi driver by profession, who had been missing along with his taxi vehicle for approximately two weeks before the recovery of the body.

2. Post Mortem Findings:

Post-Mortem Examination was conducted at RIMS, Imphal on 26/03/2024. Though the cause of death could not be ascertained due to the advanced stage of decomposition, the PM report mentioned the presence of multiple bruises.

i) Bruise over the right side of face, 10.5cm x 9cm, 2cm from the midline and 148cm above heel, red.

ii) Bruise over the right frontal-parietal region of head up to the right side of forehead, $10 \text{cm} \times 6 \text{ cm}$, 0.1 cm midline, 150 cm above the heel, red.

iii) Bruise over the right shoulder extending up to the right upper arm, $26\text{cm} \times 20\text{cm}$, 3cm above the wrist, red.

iv)Bruise over the right side of upper chest, 10 cm x 5cm, 11cm from midline, 120cm above heel, red.

These injuries suggest ante-mortem trauma, raising strong suspicion of homicidal violence.

3. Witnesses Examination and Suspicious Circumstances:

- i) During enquiry, a key witness stated that Mufiz Uddin (33 Yrs) @Mona, Indra and AbijUddin (face covered) sold him an Alto car on 14/03/2024 (before the recovery of the deceased's body).
- ii) The same witness further stated that on the next day i.e.15/03/2024, Mufiz Uddin @Mona approached him at Dungrei Junction and threatened him not to disclose his name to anyone regarding the sale of the car. He warned that if his name was mentioned, he would kill the witness's wife.

iii) It has also come to light that the deceased had been working as a taxi driver under Mr. Mona. Despite the deceased and the vehicle going missing, Mufiz Uddin @Mona neither reported the incident to the police nor made any enquiries.

iv) The fact that Mufiz Uddin @Mona had access to the deceased's missing vehicle, disposed of it illegally along with his two friends, and later issued threats, is highly suspicious and strongly indicates his involvement in the death of the deceased and possible destruction of evidence.

In view of the above findings, the investigating officer humbly requested for conversion of U.D. case No. 01/UKL-PS/2024 dated 25/03/2024 into a regular FIR, and for taking necessary legal action against the suspect, Mufiz Uddin (33 Yrs) @Mona,Indra and Abíj Uddin.

Hence the complaint case under GD entry No.01/UKL-PS/2024 U/S 174 Cr.PC dated 25/03/2024 is converted to regular FIR No. 04(06)2025/UKL-PS U/s 103(1)/3(5) BNS dated 03/06/2025.
