Sir,

1. 36 Assam Rifles had been tracking the movement & activities of the apprehended individuals namely:-

- Mr. Samuel Kamninhao, Age 20 yrs s/o Haomang, Village-Singhat, Dist-Churachandpur.
- Mr. Hegun Seimingun, Age 21 Yrs s/o Thangpao, Village-E Cananphai, Dist-Churachandpur.
- Mr. Thangminhou Touthang, Age 22 Yrs s/o Seimang Touthang , Village-E Cananphai, Dist-Churachandpur.
- Mr. Mangkhohao Touthang, Age 38 Yrs s/o Onhem Touthang, Village-Thangbuh, Dist-Bishnupur.

2. Based on credible intelligence inputs received from tech int and own sources regarding the presence of four hardcore CKMA (IMBVV) a non SoO group cadres in general area village Kerith, Rengkai Churachandpur who were reportedly involved in weapon smuggling, issuing extortion demands and threatening civilians at gunpoint, a meticulously planned operation was launched by 36 AR. As per intercept, these cadres were demanding 10 lac rupees from Mrs. Lamsi of Lajangphai and later on we got to know that they have demanded Rs. 10 lac each from other two persons also. They went to Lamsi's residence on 02 Jun at around 2000 hrs and left one bullet with her son, threatening to tell his mother to report today ie on 03 jun 2025 at 1000 hrs with Rs. 10 lac else they are going to kill him. They were also carrying weapons to Lamsi's house but that couldn't be recovered during Operation. Statement of CKMA organisation is attached as exhibit-1.

3. At approximately 0030 hours on 03 June, 2025, a column led by Naib Subedar Tara Sunar moved out from Bn HQ Veng for Vill Kerith. The team was divided into multiple components and the target area was cordoned quitey and effectively, denying all

possible escape routes to the suspects. At 0330 hours the search team apprehended the four individuals in general area village Kerith, Rengkai, Churachandpur.

4. During the search, the following items were recovered from their possession:

- (a) Two 09 MM live Rds.
- (b) 03 Mobile Phone.

5. All four individuals are active members of the CKMA outfit and have been involved in transporting illegal arms and war-like stores.

6. It is requested that an FIR be registered under relevant sections of BNS.

7. Ground of Arrest- Threatening & intimidating, extortion demand in Lajangphai and other villages.
