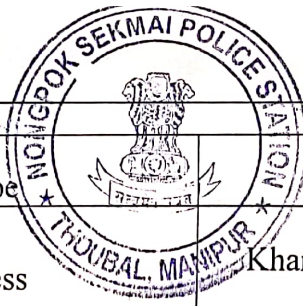

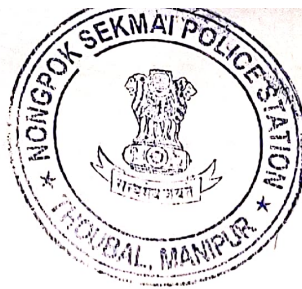

Sir,

On 02/04/2025 at 4.00 pm a team of OC/NSK-PS, CDO Unit Thoubal led by SDPO/YPK went on a surprise round checking within the PS jurisdiction to check for illegally sand mining stone quarrying as there have been recent complaint about the same.

On reaching Lungthar village the team have found a group of people engaged in mining stone quarrying. On asking about the permits the owner failed to provide any documentation. On spot inspection the team found a stone crusher being run illegally. On verification the people present there failed to provide any credible reason for their presence at the spot.

Consequently, the vehicles present at the spot were seized and the people present were arrested.




As per judgment the Hon'ble High Court of Manipur imposed in 2019 for re-preservation of Thoubal river vs State of Manipur a comprehensive ban on unauthorized stone quarrying and sand mining in all the rivers across the state. The division bench, comprising Chief Justice Ramalingam Sudhakar and Justice Kh. Nobin emphasize that no one individual is permitted to engaged in such activities without a valid license or lease granted in accordance with the law

Furthermore, seeing police personnel doing seizures and arrest a large crowd gathered thus the necessary legal proceeding could not be completed on-site. Therefore, the seized items and arrested individuals were brought to NSK-PS for further legal procedures.
