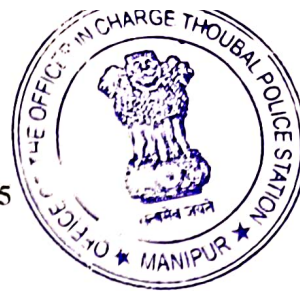

With due respect, I the undersigned have the honour to report an incident that occurred today i.e. 29/05/2025 at around 2.00 pm, at Khangabok Makha Leikai, near Popular Youth Club, Thoubal. That, my younger brother Moirangthem Bobby Singh (31) yrs S/o M. Tomchou Singh & my cousin brother Moirangthem Arun Singh aged about 17 yrs S/o M. Ngangba Singh both resident of Khangabok Makha Leikai, Thoubal near Popular Youth Club were physically assaulted by (1) Saikhom Romen Singh (37) yrs s/o S. Chaosana Singh, (2) Saikhom Raman Singh (28) yrs S/o S. Itomcha Singh, (3) Saikhom Premjit Singh (39) yrs S/o S. Manitomba Singh & Saikhom Santosh @ Mittao Singh (27) yrs S/o S. Chaoba Singh - all resident of Khangabok Makha Leikai, near Popular Youth Club, Thoubal for unknown reason. As such they received injuries on their persons and evacuated to District Hospital, Thoubal for medical treatment and further refer to Higher Hospital.
