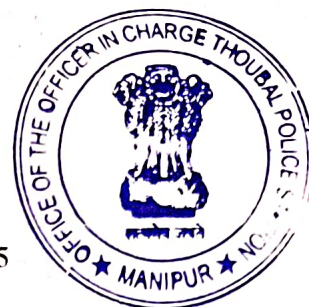

Sir,

As directed, it is to inform you that on 29.05.2025, one Md. Liyakat Ali (aged about 43 years), S/o Md. Maheruddin of Thoubal Moijing Wangmataba, Thoubal District, Manipur had identified himself as Peon of Sub-Divisional Officer, Lilong by producing an ID card bearing EIN No. 12081 issued by Office of the Deputy Commissioner, Thoubal and a Salary Certificate issued by the Office of Sub-Divisional Officer, Lilong while he stood as surety in connection with Cril. Misc. (Bail) Case No. 29 of 2025 Ref: FIR No. 21(03)2025 LIL u/s 303(2) BNS, 2023 (State of M. vs Meraimayum Nadim).

On further enquiry from the Office of Sub-Divisional Officer, Lilong, it is confirmed that the said person is not an employee of SDO, Lilong neither they had issued ID card and Salary Certificate to him.

It is therefore requested to take appropriate legal action against Md. Liyakat Ali and all persons helping him in preparing/producing the said fake documents.
