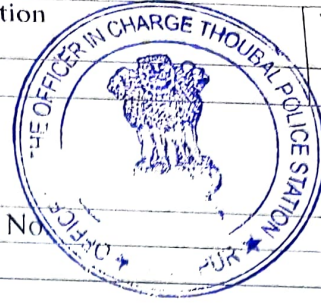

11. First Information contents: Today i.e 09/06/2025 at 09.00 pm, received an information that on the same day at around 08.45 pm, a large number of unknown people holding/carrying object of different discrimination which can be used as offensive weapon by defying the Prohibitory order of DM/Thoubal vide order no. 4/65/DC(TBL)/2009/L&O/2024 dated 07/06/2025 approached towards the gate of the District Police Headquarter, Thoubal in pretext of one Surjakanta of Heirok being picked up by security personnel from Wangjing area. Accordingly, some representatives met with SP/TBL and told them that no such individual was apprehended/picked up by District police, TBL. Thereafter the unknown people turned into an unruly mob who were waiting in the District Police Headquarter, Thoubal by taking advantage of the situation, they began destructing/vandalizing office property by pelting stones, catapults as well as firing of several live rounds were also heard from among the unruly mob. The unruly mob stormed towards the main gate of the District Police Headquarter, Thoubal and started attack to police personnel as well as CAPF personnel who were already deployed to counter any untowards situation. The police teams directed the unruly mob to disperse by giving due repeated warning. Thereafter, minimum forces were used in order to control the unruly mob thereby some tear smoke munition and stun grenade were fired. As the situation was out of control, some live rounds were also fired by the security personnel in the safe direction to deter the unruly mob. While controlling the unruly mob, some security personnel were injured. Hence the case.
