Sub :- Lodging of FIR against unknown miscreants for stopping the Govt vehicle, stone pelting, damage to Govt. vehicle and injury to 02 BSF personnel and 01 civil driver while enroute to SP office thoubal for reinforcement on 09-10th June 2025(intervening night) at about 1125 Hrs.

Sir,

It is to inform that on the night intervening 09-10th June 2025 at about 2325 hrs, while the joint QRTs team (THQ, D/111 BN BSF) adhoc XVI BN BSF led by Sh. Narendar Kumar Commandant/2IC, Sh. Krishan Kumar DC/Adj, Insp Rabi Narayan Swain Offg Coy Comdr along with 2 officers 5 SAs and 27 Ors on the requisition of the police were moving from 3rd IRB campus towards SP office Thoubal for reinforcement, The gathered mob on the road attached at the BSF QRT resulting in the damage of Govt and Civil Vehicle which details are as under;

1. AS 11 F C0287 407 from 105 BN BSF got damaged at right side side mirror broken, right side body dent, side door dent.
2. AS 11FC0824 TATA 5 Ton of 34 Bn BSF got damaged front glass broken, right side wind glass broken, right side door upper side dent, left side cabin HOD dent.
3. AS 11 AA 5337 Bolero Neo of 111 BN BSF full body dent, all glasses gate front & rear, window wind screen got broken, side mirror (Both side fully broken fuel cap dent, back tail light (right side broken)
4. A Civil vehicle MNO1AK 0815 Scorpio left side middle doors window glass broken, front door dent, left side both door dent, front and back side glass broken, front bonnet left side dent, front upper roof dent.
5. BP Gypsy Modified no. AP23H4699 head light broken attached with Coy Ex-152 BN BSF a/w 04 SAs and 16 Ors Total-21 pers Adhoc of M&C XVI Bn BSF left for reinforcement while enroute to SP Office Thoubal , at about 082340 hrs miscreants approx. 500 were assembled on both side near Khangabok market of the PS and tried to stop the QRT vehicles forceful.

The **civil vehicle Scorpio Regt No MN01AK0815** driven by **Sh Sabir khan** got damaged. Similarly, CT Amit Shukla got minor injuries on his right leg and CT Praphat Kumar got injuries on RT wrist. Due to hitting the vehicles with bamboo sticks therefore, troops immediately retaliated in self defence and tried for dispersing the mob, during retaliation 01 rounds of 5.56 MM ball of Insas was fired in the Safe

direction and tear smoke shell-06 stun shell normal 07 and stun lac 07 were fired by the QRT total 5 smoke shell were fired by the D/111 troops

In scuffle with mob/miscreants damaged the above mentioned Govt/ Civil Vehicle. After opening of lethal and Non-lethal fire by the troops in air, re-enforce to the SP office was provided on 9th June 2025 at about 2350 hrs.

In self-defence 13 rounds of 5.56 MM Insas were fired but empty case (EFCs) were not recovered due to darkness/market area in the volatile situations. The miscreants/Mob constantly pelted stones on the Govt /Civil Vehicles and damaged them which were engaged. In execution of Govt bonafide duty as to re-enforce the SP office Thoubal by QRTs BSF.

Therefore, it is requested to register a FIR against Mob/ unknown Miscreants of Khangabok/ Athokpam/Thoubal area those have damaged Govt/Civil vehicles and forcefully tried to stop Govt official from performing Bonafide Govt Duty.
