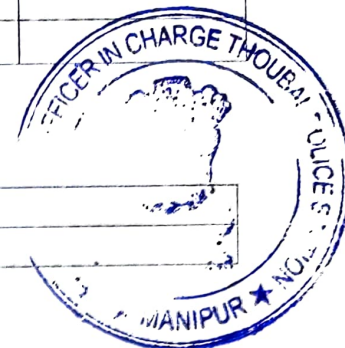

Subject: REQUEST FOR LODGING OF FIR IN R/O ATTACK OF BSF PATROL PARTY
AND DAMAGING OF GOVERNMENT PROPERTY

I am directed to report that on 10 June 2025 at approximately 1020 hours, Coy Commander Shri Kunwar Singh Rana, AC/CC of E Coy CI Post Heirok, accompanied by Regt. No. 05254572 CT/Dvr Suraj Mal, proceeded on a motorcycle patrol to assess the prevailing situation in his Area of Responsibility. As conventional vehicular movement was hindered by roadblocks laid by the local Meitei population, a motorcycle (TVS Apache RTR 160, Reg.No. AS 01 EA 6571) was used to navigate through the obstructions and gather ground intelligence.

2. While traversing several roadblocks, the patrol team reached Wangjing Bazar at approximately 1035 hours, where they encountered an additional blockade erected by members of Meira Paibi and Arambai Tenggol. In an effort to document the situation and report to higher authorities, the Coy Commander began photographing the roadblock using his mobile phone.

3. Upon noticing this, five cadres of Arambai Tenggol, along with Meira Paibi members, surrounded the personnel, forcibly snatched the Coy Commander's mobile phone bearing No. 8865812721 (IMEI Numbers 867879078871794 and 867879078871786, Manufacturer- IQOO Z10, Model-I2407 Colour-Worn) and smashed it on the road. The mob also snatched mobile phones bearing numbers 7017815884 and 9436110874 (manufactured by Redmi 9 Power) from Ct/Dvr Suraj Mal and took away both mobile phones, which could not be recovered until the lodging of the FIR. The mob started manhandling the BSF party. Recognising the potential threat to their safety, a few local women and Meira Paibi members escorted both BSF personnel into a nearby civilian house.

4. At around 1120 hours, CT/G S.K. Singh and INSP/G P. Jinda Methei from 10 Bn BSF arrived at the scene and attempted to negotiate peacefully with the agitating individuals. However, their efforts were unsuccessful, and the mob became increasingly aggressive and assaulted the BSF men. Sensing the deteriorating situation and wishing to prevent escalation, the BSF team withdrew to the nearby CI Post located at the residence of Wangjing MLA Shri M. Brojan.

5. While retreating, though INSP/G, CT/G, and CT/Dvr Suraj Mal managed to reach the CI Post safely, the mob briefly overpowered the Coy Commander and manhandled him. He received abrasions on the forehead and a minor cut on the lower lip on the right side, as well as swelling on the shin (right side of the right leg). Upon receiving the report, the Commandant, 10 Bn BSF, immediately dispatched reinforcements. At approximately 1200 hours, a team led by Regt No. 860027450 Sh B.N. Jha with 2 SOs and 7 ORs in civil Scorpio and BP Gypsy vehicles, along with another team under INSP Nikhil Sharma comprising 1 SOs and 16 ORs in a Casper and BP Gypsy, arrived at the scene.

6. The reinforcements had to resort to firing and using minimal force to disperse the crowd successfully. The details of the firing during the incident are as follows:

- CT G JAMATIA fired 04 rounds from 5. 56 LMG
- HC T D CHAKRABORTY fired 03 TEAR SMOKE SHELLS
- CT PRASHANT BEHERA fired 01 round from AK-47
- CT RAVI KUMAR fired 07 rounds from AK-47 and launched 01 NOS TEAR SMOKE GRENADE.

7. By 1230 hours, all BSF personnel were safely evacuated to CI Posts at Heirok and Wangjing.



8. During the incident, the BSF motorcycle (Regn No. AS 01 EA 6571, TVS Apache RTR 160) was set ablaze by the mob. However, the charred vehicle was recovered and returned to CI Post Wangjing.
9. You are requested to lodge an FIR in connection with the above incident against and action be taken against the miscreants who have attacked the BSF personnel on duty and burnt the government property. A copy of the FIR be provided to BSF for our further course of action
