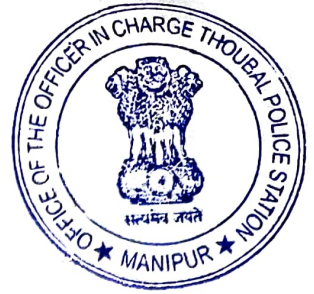

Sir,

With due respect, I am to report that on 08/06/2025 at around 6.30 pm, when I was staying at Moijing Thongjao, an information had given by my son namely Md. Ngajaoba, 19yrs stating that he and one Md. Sakir Ali, 18yrs S/o Md. Soukat Ali of Moijing Thoubalmayum Leikai were physically assaulted at Moijing near New Model English School by the following persons namely 1) Md. Ruhid, 23yrs S/o Md. Safi Khan of Moijing near New Model English School, 2) Mrs. Surma Bibi, 38yrs W/o Md. Safi Khan of do, 3) Md. Babu, 40yrs S/o (L) Md. Temba of do. 4) Md. Bobo, 20yrs S/o Md. Manal of Moijing Awang Leikai & 5) Md. Safi Khan, 45yrs S/o (L) Md. Taba of Moijing near New Model English School because of my A-Star B/R No. MN04P1187 driven by my son dashed one stationary Honda Activa (blue in colour) B/R No. unknown at the said spot. Further, I along with my younger brother Md. Akbar aged 35yrs and one Md. Riyajul Haque, 25yrs S/o Md. Abdul Haque of Moijing Lamkhair rushed there at around 7.00 pm of today and tried to make an admicable settlement regarding the incident. In the mean time, the above noted persons attacked to assault us and also beaten my younger brother and Md. Riyajul Haque without any valid reason. As a result, Md. Sakir Ali and Md. Riyajul Haque received injuries and evacuated to hospital for medical treatment. Then, they also wrongfully detained the said A-Star at the house of the above noted Sl. No. 5.

It is therefore, requested to kindly take up necessary action.
