With due regards, I beg to state that today on 12/06/2025 at about 3:40 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Leishangthem Khong Manung Ikop Pat for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 Assam Rifle led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Shivanand Surve, Superintendent of Police, Thoubal rushed to the spot immediately and launched a massive operation at 4:10 a.m. On searching the undernoted articles i.e. (1) 1(one) no. of 303 Rifle along with magazine bearing body no. 22485, (2) 1(one) no. of 12 Bore Belt Action Rifle bearing registration no. B193680, (3) 2(two) nos. of 12 Bore Single Barrel bearing registration nos. E89260 & Z20748, (4) 1(one) no. of 9mm pistol along with magazine, bearing registration S8403, (5) 11(eleven) nos. of 303 live rounds, (6) 3(three) nos. of 7.62x39mm live rounds, (7) 1(one) no. 5.56mm live round, (8) 1(one) no. of 9mm live round, (9) 1(one) no. of 45 blank cartridge, (10) 2(two) nos. of Tear Smoke Shell Soft Nose, (11) 1(one) no. of Tear Smoke Shell (Chilli) and (12) 3(three) nos. rubber bullet were found from the spot at 4:50 a.m. Hence the above noted articles were seized at 4:55 a.m. by observing formalities. The massive searched operation was conducted from 4:10 a.m. to 5:30 a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
