

I request you to kindly register my complaint and take immediate action against the culprits to justice.

I, Mrs. Sahira Bagum@Eto aged about 47 years W/o. Md Anzob Ali, a resident of Sandgaiyumpham at present Hayellabuk Mayai Leikai, am writing this letter to bring to your urgent attention a serious matter concerning a life threat that my family received. I am deeply concerned for my safety and the safety of my family and I seek immediate police intervention.

Yesterday, on 11-06-2025 at around 09:30 am Mr.Md Sahabuddin Keinoumayum So. (L) Abdur Rahman@ Jenepa aged about 75 years and Mr. Md Aji Moijingmayum S/o. (L) Moirangthou Moijingmayum aged about 70 years, both are the residence of Hayellabuk Mamang Leikai, P.O & P.S- Thoubal, Thoubal District Manipur came to my **Present** resident at Hayellabuk Mamang Leikai and to my agricultural field at Hayellabuk with the intent of harassing and threatening to my family members by using sharp weapon and sticks. I am writing this complaint against the above mentioned two persons and his accomplices, who accompanied them to our resident and agricultural field yesterday.

They had come and created another scence on 18/04/2025 at around 06:00pm. I had also filling an oral complaint against all involved in that incident too. Relevant
