First Information contents: Today i.e 13/06/2025 at 06.30 pm, received an information that on the same day at about 10.30 am, a road mishap occurred near Kodompokpi Sport Complex, Wangjing along NH102 that one unknown male pedestrian was knocked down by one Santro Car Bearing registration No. MN04A5121 (white in colour) driven by unknown driver which was proceeding from Thoubal side towards Kakching side due to rash & negligent driving on the part of driver. In that, the unknown male pedestrian received injury and evacuated to District Hospital Thoubal for medical treatment. Further, referred to RIMS Hospital due to severity. The injured pedestrian was identified as Thingujam Yaima Meitei, 52yrs S/o Th. Chaoba Meitei of Moreh Ward No.7, Heinou Makhong, PS- Moreh, Tengnoupal District, Manipur. However, he succumbed to the injury at RIMS Hospital, Imphal on 13/06/2025 at about 05.26 pm. Hence, the case.
