To

I have the honour to report that today i.e. 14/06/2024 at 11:30 a.m. while I was on normal law and order duty at DHQ Main Gate, a reliable input regarding movement of a gang of vehicle lifter along with stolen vehicles was received. And there was high a chance of escaping on the part of vehicle lifters gang, if not responded/reacted on the said input. So, after giving information to Golf-21 (Thoubal District Control Room), immediately rushed to the spot i.e. at Thoubal Moijing Awang Leikai and found a large crowd along with theft person where the angry public had shown their violent attitude towards the vehicle lifter. Then, we forcefully rescued the theft person along with the two wheeler vehicle from the spot.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure and arrest could not be done at the spot as the unruly mob started to torture the vehicle lifter and as so, we immediately move out from the spot along with the vehicle lifter and the said Motorcycle.

The aforementioned arrested person along with the seized motorcycle are handed over to you for taking further necessary action.
