Today i.e. 10/06/2025 at 02:30 pm, received a reliable information that on the same day at about 02:35 pm some local person/persons including men and women of Shikhong Khumbi village area numbering about 400/500 organised and unruly mob by holding deadly weapons i.e. iron rod, bamboo stick etc.

On received of the information, self along with police team and 2(two) teams of CDO Thoubal and 1 (one) column of 91 Bn. BSF A-Coy immediately rush to the spot. On arrival at the spot, the unruly and irrate mob started throwing stones towards the police teams. Accordingly, the police teams used minimum force by firing tear smokes, stun shells and live rounds to disperse the unruly mob and also control the mob.

Hence a regular suo-motto case has been registered under FIR No. 17(06)2025 NSK-PS U/s 191(1)(2)(3) & 3(5) BNS for investigation.
