Sir,

With due regards, I beg to state that today on 16/06/2025 at about 4:40 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Leirongthel Pitra near Canal for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle and a column of A-Coy 91 Bn. BSF led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. Hijam. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Shivanand Surve, SP/TBL have rushed to the spot immediately and launched a massive operation at 5:30 a.m. On searching and found the undernoted articles i.e. (1) 1(one) no. of 303 Rifle along with magazine Mark as P1966, (2) 1(one) no. of DBBL gun bearing registration number 67599-17, (3) 1(one) no. of 9mm Pistol along with magazine bearing registration number F2538, (4) 4(four) nos. of 36 HE Hand Grenade, (5) 4(four) nos. of Detonator, (6) 4(four) nos. of Arming Ring (7) 2(two) nos. of 9mm live rounds, (8) 2(two) nos. 12 Bore Cartridge, (9) 2(two) nos. of MK-III A2 Grenade, (10) 2(two) nos. of Stun Shell (N), (11) 3(three) nos. of Tear Smoke Shell(Soft Nose), (12) 1(one) no. of Tear Smoke Shell(Chilli), and (13) 2(two) nos. of Baofeng radio set with Charger from the spot at 5:50 a.m. Hence the above noted articles were seized at 6:06 a.m. by observing formalities. The massive searched Operation was conducted from 5:30 a.m. to 6:30 a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
