Asker Ali (45) years S/o Haji Nawab Ali of Lilong Sambrukhong Mamei in a motive to attack Md. Asker Ali. Immediately on receipt of the information, self and available men powers of Lilong PS and CDO-Teams of Thoubal rushed at the said area and tried to control the situation. The police team warned the mob to disperse from the said area. However, the mob became more aggressive and turned into an unruly mob. Thereafter the police team tried to disperse the unruly mob by using minimal force. But the situation became more worsen and the unruly mob attacked the Police team by pelting stones and the unruly mob was uncontrollable thereby stormed into the house of Md. Asker Ali (45) years S/o Haji Nawab Ali of Lilong Sambrukhong Mamei and set ablaze and vandalized the house of Md. Asker Ali and the house of Mrs. Seidan (48) D/o Haji Nawab Ali of Lilong Sambrukhong Mamei which is located on the southern side of the house of Md. Asker Ali. Reinforcement teams comprising of SP-TBL, Addl. SP (L &O) TBL, SDPO/TBL, DySP(CDO/TBL, DySP/Head Quarter-TBL, OC-CDO/TBL, along with CO, 2iC and deputy commandant of 66 Bn with QAT, CDO-I/W, 1(one) coy of D-99 Bn. RAF and 2 (two) Platoon of B-232(M) Bn. CRPF also rushed there. Due to the action of unruly mob, some personnel of Lilong PS and CRPF got injured on their persons. And the unruly mob vandalized one Gypsy and one DI vehicle of the police team. As the no. of members of the unruly mob was huge and wild, the Police team & CAPFs fired many live rounds and tear smoke shells in the air in order to disperse them. 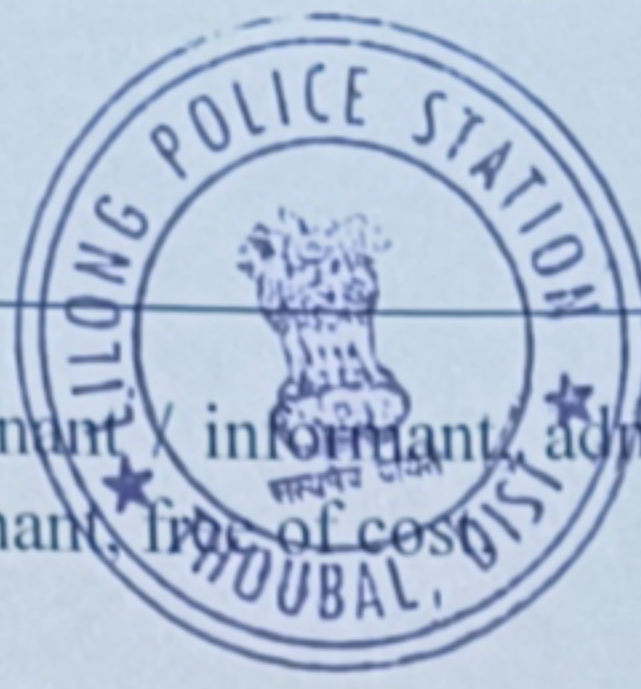


