## 12. First Information contents:

Today i.e. 09/06/2025 at around 11.40 am received an information that on the same day at around 11.30 am one vehicle Santro car, black in colour bearing registration No. MN01X-1861 driven by an unknown driver plying from Khongjom Bazar side towards Wangjing side dashed on the left side of a Bike KTM, black in colour bearing registration No. MN06SH-3868 ridden by unknown rider plying in same direction along NH No. 102 at Uningkhong near Buzuku Cafe due to rash and negligent driving on the part of Santro car. As a result, the unknown rider with two pillion riders of the KTM bike and unknown driver of Santro car sustained injuries on their person and evacuated to District Hospital Thoubal for medical treatment. Both the vehicles were also badly damaged.

Hence a regular *suo-motu* case FIR No. 26(06)2025 KJM-PS U/s 281/125(b)/324(4) BNS, 2023 has been registered for investigation.
