Subject : Report.

Sir,

With due regards, I beg to state that today on 14/06/2025 at about 5:10 p.m. received a reliable information by 10 Bn. BSF that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Tentha Samu Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police led by Shri Y. Sunanta Singh, MPS Dy.SP(HQ)/TBL and Insp. K. Nitaranjan Singh, OC/CDO-TBL along with a column of 10 Bn. BSF under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Shivanand Surve, Superintendent of Police, Thoubal rushed to the spot immediately and launched a massive operation at 5:30 p.m. On searching the undernoted articles i.e. (1) 1(one) no. of 303 Rifle bearing body no. FTR-E-38879 along with magazine, (2) 1(one) no. of 7.62mm SLR Rifle bearing registration no. 16752080 along with magazine, (3) 48 (forty-eight) nos. of 7.62x51mm (SLR) live rounds, (4) 3(three) nos. of Tear Smoke Shell(CS) and (5) 4(four) nos. of Cartridge 38mm Anti-Riot with Rubber Bullet were found from the spot at 5:50 p.m. Hence the above noted articles were seized at 5:52 p.m. by observing formalities. The massive searched operation was conducted from 5:30 p.m. to 6:30 p.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
