Today i.e. 27/04/2025 at 04:20 pm received information that, on the same day at about 04:15 pm, one KTM-Bike Orange in color B/registration number.MN 01AH-4213 ridden by unknown rider with one pillion rider which was coming from Thoubal towards Imphal side was hit at Lilong Tairel Makhong along NH-102 by one Maruti Van B/Regd. No.MN05J-0765 driven by an unknown driver, which was proceeding from the opposite direction on the wrong side along NH-102 due to rash and negligent riding/driving on the part of the unknown driver of Maruti Van. As a result of which, rider and pillion rider of KTM-Bike got injured on their persons and evacuated to Hospital for medical treatment. Both involved vehicles were also partly damaged.
