Today i.e. 28/3/2025 at 9:10 pm, received an information that on the same day at about 9:00 pm, one Honda Activa B/Regn. No. MN01AF-3184 ridden by an unknown rider proceeding from Imphal towards Wangjing side along NH102 met road traffic accident at the road junction of DC Office main gate, Thoubal Athokpam with one i10 Grand car B/Regn. No. MN06LA-9969 driven by an unknown driver while the said i10 Grand car was crossing the highway towards DC Office side (western side to eastern side) due to rash or negligent driving & riding on the part of the both unknown driver & rider of both vehicles. In that, unknown rider of the said Honda Activa sustained injuries and evacuated to the hospital for medical treatment. Both the vehicles were also partly damaged.

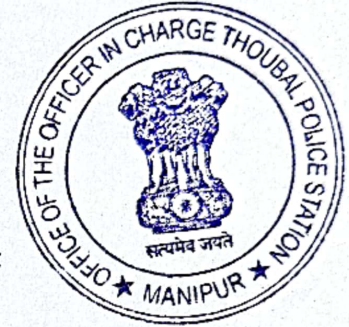
