Today i.e. 31/03/2025 at 5.15 pm received an information that on the same day at around 4.55 pm, one unknown male pedestrian knocked down by one i10 Grand car bearing regn. No. MN06L1710 driven by an unknown driver which was heading towards Thoubal side from Wangjing side along NH 102 near KM Blooming Hr. Sec. School, Khangabok due to rash & negligent driving on the part of the unknown driver of i10 car. As a result of it, the pedestrian sustained injury on his person and evacuated to hospital for medical treatment. The vehicle was partly damaged.


