Sir,

I have the honour to bring the following matter to your attention a serious incident that took place on 02 April 2025 involving an attempt to my life, physical assault and insult in public place, my name Akbar Rahaman age about 26 years, senior Geo Scientist, GOI residing in Moijing Khong Mangung.

On 02/04/2025 at around 05:20 pm, I went to visit at Kabristan upon went back from Kabristan at Moijing Zhongjao named Md. Thakeli age about 37 S/o late Muhibullah of Moijing Chingya Litan Makh confronted me, assaulted me while I trying to park my car at Moijing Zhongjao. He assault on my face led to damage my ear drum and having difficulties in hearing which is amount to insult to senior Group I officer at public place and damage to my dignity and life.
