Sir,

As endorsed, I have enquired regarding a complaint report filed by Md. Ashraf Ali of Sangaiyumpham, Thoubal stating that he was assaulted by the following individuals namely (1) Md. Hesamuddin, (2) Md. Tabsir, (3) Md. Hamid, (4) Md. Amir all son of Md. Hesamuddin & (5) Md. Ahamad Khan s/o (L) Nurkhan of Sangaiyumpham, Thoubal on 04-04-2025 at around 3:40 pm at Sangaiyumpham Cherapur part II near the residence gate of Md. Ismad Khan (30) yrs. It refers to G.D. entry no. 19/TBL-PS/2025 dated 04/04/2025.

The complainant was examined and a copy of OPR (out patient record) of District Hospital Thoubal was also collected in which the concerned Doctor described the injury as Lacerated injury. Thereafter, he was further admitted at Peace Hospital and Research Institute Porompat, I/E on the same day i.e. on 04/04/2025. On examination, the complainant stated that he was assaulted by the 8 (eight) individuals namely (1) Md. Hesamuddin @ Hesam Moulubi (68) yrs S/o Late Md. Mahamuddin, (2) Md. Tabsiruddin @ Tapsi (47) yrs S/o MV. Hesamuddin, (3) Md. Hamid Khan @ Akhan (40) yrs S/o Md. Hessamuddin, (4) Md. Amir Ahamad @ Amir (27) yrs s/o MV. Hessamuddin, (5) Md. Zuma Khan (25) yrs S/o MV. Hessamuddin, (6) Md. Hamad (23) yrs S/o (I) Md. Nurkhan (7) Md. Mirsarif @ Putra (23) yrs S/o MV. Hesamuddin, (8) Md. Ismad Khan (30) yrs S/o Late Md. Nurkhan, all are resident of Sangaiyumpham, Thoubal but he could not mentioned their detail particulars during the submission of report as he forgot their names. On 08/04/2025, a copy of discharged certificate of the complainant was received describing nature of injuries as Head injury and fracture of ribs.

Base on this report of the Doctor, it is ascertained that a cognizable offence has been committed by the above named accused persons.

It is therefore requested to kindly take up a regular FIR in this regard.
