11. First Information contents: Today i.e. 21/4/2025 at about 8:10 am, based on the complaint report submitted by Waikhom Yaima Meitei aged about 84 yrs s/o late W. Anganghal Singh of Athokpam Mayai Leikai and 5 others on 20/4/2025 for providing police protection/security to their family members, properties, wrongful and criminal trespass to their homestead land located near Arong Bridge, Khangabok from Mr. Babu Singh, Secy VEDSCO, Khangabok along with members of the said club and local people, a team of Thoubal PS led by SI M. Surjit Mangang conducted patrolling duty in and around the above area for providing security. Thereafter, at around 8:20 am, self along with police team also left for the said place and a thorough patrolling was conducted in and around the area to thwart any untoward incidents.

At around 9:40 am, when I along with police team including SI M. Surjit Mangnag was at the said place i.e. the homestead land of Waikhom Yaima Singh located near Arong Bridge, Khangabok, some people were seen coming from the highway and nearby paddy field towards us.

Within few minutes, the number of the people raised to around 1000/1500 and a crowd was formed and turned into an unruly mob. In spite of our several attempts to bring them under control, the unruly mob became more aggressive and resorted to extreme violence and started vandalizing the structures of the ongoing pucca construction as well as Kutcha structures by overpowering the police party on duty. Immediately, the information was given to Control Room as well as Senior Officers for reinforcing the situation.

Having no alternative means, our police personnel began dispersing the mob using minimum force by way of firing Tear Smoke Munition, Mock Bomb and some live rounds towards safe direction. Several other police teams including Addl.SPs and GOs rank officers along with CDO teams arrived at the spot and managed to control the situation at around 10:40 am.

In the incident, 3 (three) concrete pillars of an ongoing construction, some parts of two kutcha houses were found partly damaged by the unruly mob. Hence, the case.
