Subject: Reporting a case of capturing and uploading of attendance of workers in worksite from printed Photographs instead of real-time capture while executing works under MGNREGA.

Sir,

In inviting a reference to the above subject, Gram Rojgar Sewak (GRS), Moijing Gram Panchayat vide her letter No. Nil dated 2nd May 2025 has reported a case of violation of guidelines of MGNREGA by mates appointed for capturing of photographs at worksite while the workers are working. On this date i.e., 2nd May 2025, on inspection of 7 ongoing works under MGNREGA for Moijing GP, GRS hasn't found any workers on 4 work sites (4 works) instead photographs have been found to be uploaded from a copy of printed paper photograph showing some workers. On received of this information, the uploaded photographs of the 4 works are verified from NREGA soft (which is a work flow based, web enabled application which is hosted at the portal <https://nrega.nic.in>), with the help of IT Manager and allegation put up by GRS are found to be correct. The registration of the four mates and muster rolls will be deleted once the demand for work period is over. (Technically immediate cancellation of registration of mates and deletion of muster roll is found unable).

It is to mention that under MGNREGA, 2005 as well as Operational Guidelines issued by the Ministry, the main functions of mates are as follows:

1. As per MGNREGA guidelines, mates are responsible for maintenance of muster rolls at the worksite including recording the names of workers on the first day of work and marking attendance every day.
2. The implementing agencies are responsible for executing the works given in Annual Action Plan for the Financial Year and Gram Panchayat is responsible for monitoring the implementation of the scheme at the village level. The mate is directly responsible for ensuring the authenticity of data in the muster rolls, and the quality of the work executed. The mobile monitoring app (NMMS) with geotagged, time stamped photographs of the workers are taken every day to ensure more transparency in the implementation of MGNREGA. It is mandatory to capture the attendance of all the workers through National Mobile Monitoring System (NMMS).
3. Gram Rojgar Sewak is responsible for recording attendance of the labour everyday either by himself/herself or through the mate in the prescribed muster roll at the worksite. They should also monitor all mate's attendance at the worksites on time and take roll calls.

It is worth mentioning that the undersigned has also issued directions in this regard vide this office letter No TBL(BDO)/NREGA/Misc/2008 dated 28th March, 2025 (copy enclosed). All GRS and registered mates have been informed that legal action, as per law, will be initiated if it is found that the attendance of workers at worksite are not taken in real time mode but through printed paper photographs.

A training of all registered mates have also been conducted by District Programme Coordinator (MGNREGA) on 16th April, 2025 at Counting Hall of Deputy Commissioner's Office Complex, Thoubal.
