With due regards, I beg to state that today i.e. 06/05/2025 at about 10:20 a.m. received a reliable information from 3<sup>rd</sup> IRB that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Wangjing Tekcham Leikai near Public Dustbin for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 3<sup>rd</sup> IRB, 10<sup>th</sup> Bn. BSF, D/111 Bn. BSF under Adhoc XVI and D/66 Bn. CRPF led by N. Suraj Singh, MPS, Addl. SP(L&O), Thoubal and Inspt. K. Nitaranjan Singh, OC/CDO-TBL and under the overall supervision of Shivanand Surve, IPS, Superintendent of Police Thoubal District have rushed to the spot immediately and launched a massive operation at 10:40 a.m. by using metal detectors. On searching and found the undernoted articles i.e. (1) 1 (one) No. of .303 Rifle along with magazine bearing Regd. No. 67415 H, (2) 1 (one) No. of 9 mm Pistol along magazine (country made), (3) 1 (one) No. of 9 mm Pistol without magazine, (4) 1 (one) Ono. of 36 HE Hand Grenade, (5) 9 (nine) Nos. of .303 live rounds, (6) 3 (three) Nos. of Tear smoke Shell soft nose (LR), (7) 1 (one) No. of Tear smoke shell (CS), (8) 1 (one) No. of Tear smoke shell (LR), (9) 1 (one) No. of Cartridge 38 mm anti riot with rubber bullet, (10) 2 (two) Nos. of Baofeng Walkie Talkie set, (11) 1 (one) No. of Kenwood Walkie Talkie set charger from the spot and seized at 11:45 a.m. The massive searched Operation was conducted from 10:40 a.m. to 12:00 noon on the same day.
