

was received regarding the presence of some persons who were involved in selling SIM cards illegally in and around Khangabok area of Thoubal District. Acting on the information, a combined team of CDO-IW and CDO-Thoubal led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, DSP(CDO)/IW, under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW after giving prior information to Thoubal District Police Control Room rushed to the said area and conducted cordon and search operation at Khangabok area. During that one suspected person was detained for spot verification and checking at the house of one Laishram Biren Singh located at Khangabok Part-III Khunou Leikai, Thoubal District. During spot verification, he identified himself as Laishram Rajesh Singh (19 yrs) @ Tomba son of the above mentioned Laishram Biren Singh of Khangabok Part-III Khunou Leikai, Thoubal District.

During preliminary verification, he disclosed that he sold SIM cards to other person with knowledge that it will be used for illegal activities. He also disclosed that he bought SIM cards from one person namely Nawaz Khan from Sangaiyumpham Cherapur Mayai Leikai area for further selling to other person. Hence, he was arrested from the spot i.e., from his residence at 01:20 pm by observing necessary formalities. From his possession, (i) one Redmi Note 9 Pro mobile handset bearing IMEI nos. 864782046680177 and 864782046680185 along with one Airtel SIM card bearing mobile no. 7085371341, (ii) one realme C33 mobile handset bearing IMEI nos. 863261067469373 and 863261067469365 along with two Jio SIM cards bearing mobile nos. (a) 8415845313 and (b) 6009129533 and (iii) one Aadhaar card were seized at 01:29 pm by observing due formalities.

Immediately, our team along with the arrestee rushed to Sangaiyumpham area and successfully detained the above mentioned Nawaz Khan in front of a shop located at Sangaiyumpham Cherapur Mayai Leikai Part-II, Thoubal District as pointed out by the arrestee for spot verification and checking. During spot verification, the detainee identified himself as Md. Nawaz Khan (27 yrs) @ Wash Khan S/o. Md. Rafiuddin of Sangaiyumpham Cherapur Mayai Leikai Part-II, Thoubal District. During preliminary verification, he disclosed that he sold SIM cards to other person with knowledge that it will be used for illegal activities. He also disclosed that he earlier sold some SIM cards to the above mentioned arrestee for further selling. Hence, he was arrested from the spot i.e., in front of the shop located at Sangaiyumpham Cherapur Mayai Leikai Part-II, Thoubal District at 01:42 pm by observing necessary formalities.

From his possession, (i) one Redmi 4 mobile handset bearing IMEI nos. 866759037147406 and 866759037147414 along with two SIM cards bearing mobile nos. (a) 8014864387 (Airtel) and (b) 9436058605 (BSNL), (ii) one Redmi mobile handset bearing IMEI nos. 864391042205615 and 864391042205623 along with two SIM cards bearing mobile nos. (a) 9233964607 (Airtel) and (b) 8787593363 (Jio), (iii) one Aadhaar card, (iv) one side bag blue in colour containing: (a) one notebook, (b) five nos. of Airtel 5G Plus MNP SIM cards (three with black cover and two with white cover), (c) twelve nos. of Airtel 5G Plus Prepaid SIM cards, (d) eight nos. of Jio SIM cards (e) sixteen nos. of BSNL 4G SIM cards and (f) one Biometric Fingerprint Scanner were seized at 01:49 pm by observing due formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
