In submitting herewith, the enquiry report of the above referred complaint, I am to state that an anonymous tip from the Intelligence unit (xxxxxxxxxxxxx) have been received on 6/4/2025 regarding systematic campaign on the social media to peddle fake news or negative/provocative posts in order to provoke the sentiments of the Meitei's and the Kuki's. Hence, an enquiry case as referred above was registered and enquired into.

During the course of enquiry, the uploaded tweet post by the social media accounts : **The Proud Indian@DynastyDoungel**, **Dr. Lamtinthang Haokip@DrLamtinthangHK**, **HS Benjamin Mate@BenjaminMatel**, **Arijit Nobody@kalkibegins**, **Wind of Change@Saikot@WindofChange202**, **CHIKIM-TE-AWGIN@chinkukimizogin**, **Maj Digvijay Singh Rawat**, **Kirti Chakra@Dig\_raw21**, **Agnostos THEOS** (End Gaza

**Demonicide)@singhisms, Mr.Steve GrinD@YumnamStephen, Kangleipak Information Bureau@yaiphaba07, BimoL L@Bimol27lyz, SweetAnnie@annieNgashepam** has been checked and found to be consistent and corroborative with the facts of the case. The list of social media handles has been found to spread narratives that are likely to instigate violence/communal hatred in the already charged ethnic atmosphere of the State.
