I have the honour to report that on 23/05/2025 at about 1:00 PM while monitoring social media platforms, the SMMC team came across a Facebook account under the name "Manipur Stylish" having profile URL link <https://www.facebook.com/ManipurStyle>. The said user has uploaded instigating and provocative post, which could have severe repercussion in the law and order of the state. On 23 may 2025 at 10:02 Hrs, the said Facebook handler uploaded a post stating 'We, ARAMBAI UNIT 58 (COBRA TEAM), proudly hoisted the SALAI TARET flags atop Shirui Hills during the ongoing Shirui Lily Festival 2025. We, the Arambai Tenggol, raised the SALAI TARET flags as a bold declaration that Arambai Tenggol stands strong across every corner of our land. This is our sacred soil- no other community has the right to stake any claim over the land of Manipur' having post URL link <https://www.facebook.com/ManipurStyle/posts/pfbid0W6Y28VXpeayAWXrsvLNFg4g68gwqFcmGPjMX6zLpgMs7X4a8PtqHgza48iHs6tEql>.

Such posts could mislead the general public with the intent to provoke and incite hatred among communities. It is, therefore, requested kindly to take necessary formalities against the said Facebook user.




