Subject: Request for Filing FIR against Mr. Chhotubhai Vasava for Hurting the Sentiments of Indigenous People of Manipur by Labeling the Salai Taret Flag as a Terrorist Flag.

Sir,

I have the honour to state that an individual named Mr. Chhotubhai Vasava, former MLA of Gujarat and founder of the Bharatiya Tribal Party, made a highly offensive and misleading post from his X (formerly Twitter) account, @Chhotu\_Vasava, on 23rd May 2025 at 1:14 PM.

In the said post, he shared an image of the post of "Manipur Stylish" depicting some youths from the group "ArambaiTengol" holding the Salai Taret Phiral@ Flag (the sacred Seven Clan Flag representing the indigenous communities of Manipur) and made the following statement as

"Dear Hon'ble Governor @BhallaAjay ji, it has come to our notice that ArambaiTengol Unit 58

(Cobra Unit) has unfurled terrorist flags at Shirui Hills. We request that you as @Manipur police take stringent action against them immediately. @PMOIndia @HMOIndia"(Attached Copy of the original post as evidence)

His reference to the facebook account namely "Manipur stylish" post implies that the sacred Salai Taret Flag as a "terrorist flag," Mr. Vasava has gravely insulted the cultural identity and heritage of the indigenous people of Manipur. The Salai Taret Flag is a symbol of the seven clans of the indigenous communities of Manipur and holds immense historical and emotional significance. Labelling it as a "terrorist flag" amounts to a direct attack on the dignity and identity of the indigenous people of the Manipur and promotes misinformation and disharmony.

Such a defamatory and communally sensitive post constitutes a serious offence and hurts the religious, cultural, and ethnic sentiments of the indigenous people of the state (Manipur). It also poses a potential threat to public peace and harmony.

Therefore, I humbly request you to register an FIR against Mr. Chhotubhai Vasava under appropriate sections of any relevant laws, and take necessary legal action to bring justice to the people of Manipur.
