Subject: APPLICATION FOR FILING FIRST INFORMATION REPORT FOR DISSEMINATION OF SEDITIOUS DEFAMATORY AND COMMUNALLY INFLAMMATORY CONTENT BY TWITTER User "@undeterredchanu" (Username: Anamika)

Sir,

1. Please refer to the multiple tweets and posts attached with the application were had been found on today i.e 24/6/2025 at around 10:00 am which are being published and circulated by one Twitter account holder with the handle @undeterredchanu (Username: Anamika) over the past several

months. The content posted by the said user contains serious, defamatory allegations and unsubstantiated claims directly targeting the Assam Rifles, an Armed Force of the Union. These statements are malicious in nature, clearly intended to vilify the image of a lawful force deployed under Government orders in aid to civil authority, and to foster ill-will amongst communities. The posts are communally sensitive and capable of inciting public disorder in the volatile environment currently prevailing in the State of Manipur.

- 2. In addition to maligning the image of the Assam Rifles, the said account has been systematically targeting individual service personnel, including serving and retired Armed Forces officers, through the deliberate proliferation of personal data, photographs, and baseless allegations—all of which have been circulated without any credible mandate, lawful authority, or evidence. These deliberate disclosures are not only unlawful but also pose a direct security risk to the targeted personnel and their families, especially in operationally sensitive regions. Such attempts to personally vilify officers of the Armed Forces—currently or formerly in uniform—are prejudicial to the morale, discipline, and dignity of the Forces and directly harm national interest and matters pertaining to National Security.
- 3. The malicious activities of the said user prima facie attract the following provisions of law under Bharatiya Nyaya Sanhita (BNS), 2023:
- 3.1. Section 152 Act endangering sovereignty, unity & integrity of India.
- 3.2. Section 196 Promoting enmity between different groups
- 3.3. Section 356 Defamation
- 3.4. Section 352 Intentional insult with intent to provoke breach of peace
- 3.5. Section 353 (1) (b) and 353 (2) Statements conducing to public mischief
- 3.6. Section 351 Criminal intimidation
- 3:7. Information Technology Act, 2000:
- 3.8. Section 66D Impersonation and communication using electronic means
- 3.9. Section 66E Violation of privacy
- 3.10. Section 66F Cyber terrorism
- 3.11. Section 67 Publishing or transmitting obscene or offensive material (if applicable)
- 3.12. Section 69A -Powers to block access to information prejudicial to sovereignty, public order
- 3.13. Section 72 Breach of confidentiality and privacy.
- 4. In view of the above and considering the prevailing law and order sensitivities in Manipur, the repeated and public circulation of such provocative content against Armed Forces personnel, and the unauthorized sharing of their personal details by the handle @undeterredchanu, it is earnestly requested that an FIR be lodged and investigation be initiated at the earliest. The said account's activity qualifies as a deliberate campaign of cyber harassment and disinformation with an aim to target Government, Government agencies and create an environment of public unrest in the sensitive region of the country which is liable to be prosecuted under relevant criminal and cyber laws.
- 5. A request is also made to initiate necessary criminal proceedings for digital forensic tracing of the account, seek preservation of its activity history from the Twitter platform (X), details of the handlers and block the said handle in public interest until completion of inquiry.
