I have the honour to state that today i.e 15/07/2025 @ 1:00 pm, a random frisking and checking was conducted at T Khullen Naka Check point by SOT (Special Operation team) Senapati Police along with D-78 CRPF under the supervision of OC-SPT-PS Inspector Nehgoulien Kipgen and under the overall supervision of SP/SPT Dist. Shri SM Zaib Zakir, IPS. While conducting frisking and checking, one vehicle I20 car S Dust in colour bearing Reg. No. MN03P8268 was seen coming from Imphal side towards Senapati. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as Makakmayum Firdosh Sharif (26) yrs s/o MK Abdul Helim of Yairipok Tulihal Awang Leikai, Tulihal, Imphal East. On checking the vehicle, suspected WY tablets (amphetamine) was found concealed under the bonnet of the vehicle. As such DC/KPI was intimated by my senior officer and a request was made to depute one magistrate. Accordingly, SDC HQ/EM-KPI Shri. Lhunkhopao Touthang (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the driver namely, Makakmayum Firdosh Sharif (26) yrs s/o MK Abdul Helim of Yairipok Tulihal Awang Leikai, Tulihal, Imphal East, the vehicle was thoroughly checked. On checking three packages of suspected WY Tablets were found concealed under the bonnet of the vehicle.

The 3(three) packages suspected to be WY Tablets were opened in presence of the driver and the Executive Magistrate. On opening the three packages, 50 (fifty) small packages each were found in each package. On opening all the small packages, 29,974 (twenty nine thousand, nine hundred and seventy four) suspected WY Tablets were found. Weighing of the seized items was done in presence of the Magistrate and witnesses by observing formalities. The weight of the seized items is 3.172 kg including the plastic covers. The approximate value is Rs. 23,97,920/- (twenty three lakhs ninety seven thousand nine hundred and twenty). The 3(three) packages (29,974 Tablets) of suspected WY Tablets were seized in the presence of the Executive Magistrate and witnesses by preparing a formal seizure memo. The detained person was formally arrested by observing formalities at 4:30 pm.
