Sir,

I, Waikhom Ibomcha Singh (40 years), s/o. W. Irabot Singh of Bashikhong Kongba Irong, Imphal East, have the honour to report that on 20/06/2025 at about 08:00 a.m., I went to my agricultural-field to work relating the agricultural activity. I returned at my home at about 10:00 a.m. after some worked thereon and I found the Iron/safe Godrej was broken and I have lost some valued-items of my house including a gold valued of 1 san (that I bought for my daughter), a cash amount of Rs. 50,000.00+ 2,000.00 altogether Rs. 52,000/- (Rupees fifty-two thousand only) and my personal M.I. mobile-phone handset which a SIM Card registered with my personal contact no. 841491 6668. On my personal information, I learnt that one elder brother of my wife namely Moirangthem Sunil Singh, s/o. late M. Rameshor Singh of Khangabok Sorokwangma near K.M. Blooming School, Khangabok, Thoubal District along with some other numbering about 10 persons came to my home and they left along with my wife namely Moirangthem Bebithoi Devi. The said my wife took my child namely baby Linthoi (9 years) against my will. They jointly carried away the aforesaid valued items and the aforesaid cash amount without my consent after entered my house and broken down the Iron/safe Godrej. This amount was repaid by one Ningombam Hollendro Singh of my locality and Smt. W. Jandho Devi of my locality engaged me to borrow the said amount for using in her ailment related to her nephron-problem (5 Photographs of the broken Iron Godrej/almirah enclosed for reference).

It is, therefore, requested to recover those above-referred items from the above named persons that they have taken as soon as possible.
