Subject : Report.

Sir,

I have the honour to report that today i.e. the 30th June, 2025 at about 3:30 p.m. received a reliable information about the presence of an active member of the outfit KCP at Keirao area of Imphal East District. Based on the said information, a combined team of CDO/IE Unit rushed to the said area and conducted a searched operation at Keirao Khunou, Imphal East District, under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Ak Sadananda Singh, MPS, in charge Addl. SP(Ops)IE.

In that, one suspicious unknown person was detained for spot verification at Keirao Khunou near MAASI (Manipur Adventure and Elite Sports Institute), Imphal East. On verification, the detainee identified himself as one Khoirom Ingoton Singh @ Tomba (48 years) S/o Kh. Biren Singh of Keirao Lairembi Leikai, Imphal East. On further verification, the detainee stated that he is an active member of the outlawed outfit KCP (Noyon/MFL) group joined through one Mr. Yamba of KCP (NOYON/MFL) group in the month of December, 2024 and presently working under the command of one s/s – Deputy Finance Secy. Mr. Bobby of KCP (Noyon/MFL). The detainee further stated that on the advice of the said Mr. Bobby, he is involved in extortion activities from various schools located at Imphal-East District. So, the detainee was arrested from the spot i.e. Keirao Khunou near MAASI (Manipur Adventure and Elite Sports Institute), Imphal East at 4:45 p.m. by observing due formalities.

On further examination of the arrestee, it came to learnt that he kept conceal one BP jacket, one helmet and some radio wireless set inside the building of MAASI Keirao Khunou, Imphal East. Our team along with arrestee rushed to the said building and on the instance of the arrestee seized; (i) one BP jacket along with one BP plate, (ii) one Helmet, (iii) 3 (three) nos. of radio wireless set along with one Charger and (iv) one mobile phone (Realmi 14 Pro 5G) bearing IMEI no. 861491074821637 & 861491074821629 along with two SIM cards bearing no. Airtel – 9366890528 & BSNL - 9402981303 were seized at the spot i.e. inside the building of MAASI, Keirao Khunou, Imphal East the 6:16 p.m. by observing due formalities.

On the suspicious nature of the arrestee, further thorough verification was conducted in which he disclosed that two nos. of fire arms are kept concealed at Keirao Awa Ching, Chahui Makhong, Imphal East. Immediately, our team rushed to the said place and conducted a thorough searched operation of the place. In that, on the instance and pointing of the arrestee recovered one single barrel gun and one 9 mm pistol loaded with two live rounds in the magazine wrapped by one cloth, white and red in colour.

The recovered arms and ammunitions ; (i) One single barrel gun marked as 'IN PEMSA-12 SBBL LONGRANGE 38202/21' (ii) one 9 mm Pistol marked as '9 MM PISTAL, RUSSIA No. 0581' loaded with two live rounds in the magazine and (iii) One cloth, white and red in colour were seized at the spot i.e. Keirao Awa Ching, Chahui Makhong, Imphal East at 9:25 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
