Sir,

I have the honour to report that today i.e. the 6th July, 2025 at about 12:00 p.m. received a reliable information from our own intelligence about the presence of some anti-social social elements at Irilbung area of Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit conducted a searched operation at Irilbung and its adjoining area at around 1:00 p.m.

In that, three suspicious unknown persons were detained for spot verification at Keirao Khunou, near Excise Office Gate, Imphal East District. On verification, the detainees identified themselves as ; (i) **Laishram Vishan Meitei @ Bhojo @ Nongthon (28 years) S/o L. Bimol Meitei of Lamphel Sana Keithel, Lamphel Police Station, Imphal West District,** (ii) **Wangjam Holand Singh @ Nongpok (16 years) S/o. W. Pari Singh of Thoubal Khunou Makhai Leikai, Thoubal PS, Thoubal District and** (iii) **Phairenbam Johnson Singh @Thakappa (17 years) S/o Ph. Ibungo Singh of Moirang Khunou Tera Makhong, Moirang Police Station, Bishnupur District.**

On further verification, the detainees stated that they are active cadres of the outfit PREPAK. The first detainee (**Laishram Vishan Meitei**) stated that he joined the said outfit through one Mr. Gandhi of PREPAK from Langol, Imphal West in the month of January, 2025. The second detainee, **Phairenbam Johnson Singh** stated that he joined the outfit through one Mr. Naoba of Phoujakhai, Bishnupur in the month of February. The third detainee, **Wangjam Holand Singh** stated that he joined the outfit through one Mr. Binanda of PREPAK from Langol, Imphal West in the month of March, 2025 respectively.

They further stated that they got their basic military training for 45 days at Phumlenpat, Kakching District under the command of one Mr. Inungnganba of PREPAK. They are presently working under the command of one Mr. Wangba @ Yohenba of PREPAK from Thingungei, Bishnupur.

So, the first detainee **Laishram Vishan Meitei @ Bhojo @ Nongthon (28 years) S/o L. Bimol Meitei of Lamphel Sana Keithel, Lamphel Police Station, Imphal West District** was arrested from the spot i.e. Keirao Khunou near Excise Office Gate, Imphal East District at 1:21 p.m. by observing due formalities.

The second and third detainees namely; (i) **Wangjam Holand Singh @ Nongpok (16 years) S/o. W. Pari Singh of Thoubal Khunou Makhai Leikai, Thoubal PS, Thoubal District and** (ii) **Phairenbam Johnson Singh @Thakappa (17 years) S/o Ph. Ibungo Singh of Moirang Khunou Tera Makhong, Moirang Police Station, Bishnupur District** were apprehended at the spot i.e. from Keirao Khunou near Excise Office Gate, Imphal East District at 1:25 p.m.

Therefore, the arrested and the apprehended persons are being handed over to you for taking up further necessary legal procedures.
