- Through sustained efforts to cultivate sources and build an effective intelligence network, 37 Assam Rifles had been tracking a notorious arms supplier and suspected cadre of Chin Kuki Liberation Army (CKLA), a non SoO group in Gangpimual area from last one month. The unit received timely and actionable information regarding transportation of a major consignment of arms to CKLA which was further validated through TECHINT and HUMINT. The consignment was about to be transported to the banned outfit, however, at approx. 1500 hrs on 24 June 2025, a column of 37 Assam Rifles was launched as preemptively to nab the suspected cadre and consignment before it is transported to CKLA
- The column immediately rushed to general area Gangpimual and established a cordon after identifying the suspected house by 1800 hrs, however, on witnessing the heavy buildup of security forces in the area, suspected cadre under cover of darkness tried to escape from the location along with the consignment, however, the column ex 37 Assam Rifles chased the individual. With sheer disregard to own safety and ensuring strict fire control, the column commander overpowered the suspected cadre and apprehended him at 1900 hrs. Also, to prevent the escalation, crowd build up and smooth extrication, local police was informed. The column apprehended the individual and recovered huge cache of arms and ammunition.
