### FIRST INFORMATION REPORT

- Based on the intelligence gathered from recent previous operations & in continuation of development of intelligence network & mapping of drug peddlers (Op New Lamka dt 10 May 2025 & Op Mongkot Khopi dt 22 May 2025), further inputs of drug traffickers was received. Therefore, a deliberate plan was devised by 37 Assam Rifles to busy the drug cartel. Contact numbers acquired from apprehended individuals of previous operations were put under constant surveillance through 11 WEU & corroborated by own sources on ground.
- In continuance with these efforts, a specific input was received on 25 Jun 2025 at around 1230 hrs regarding presence of drugs at a house in Vaal Veng, general area Lanva bridge. Column ex 37 Assam Rifles launched an operation at around 1345 hrs. After tracking the suspect covertly, the team was able to locate the house of the suspect.



3. The house of the accused was cordoned and search, revealing approx. 14,400 WIY (Methamphetamine) tablets weighing approx. 1.503 Kgs worth approx. Rs 1.2 Crore hidden in a secret chamber made in the bed. Along with the tablets were 06 x soap cases of suspected No. 4 Heroin weighing approx. 147 gms worth approx. Rs 29 Lakhs. According the suspected person namely Mr Pau Khaw Mung was apprehended at his home.

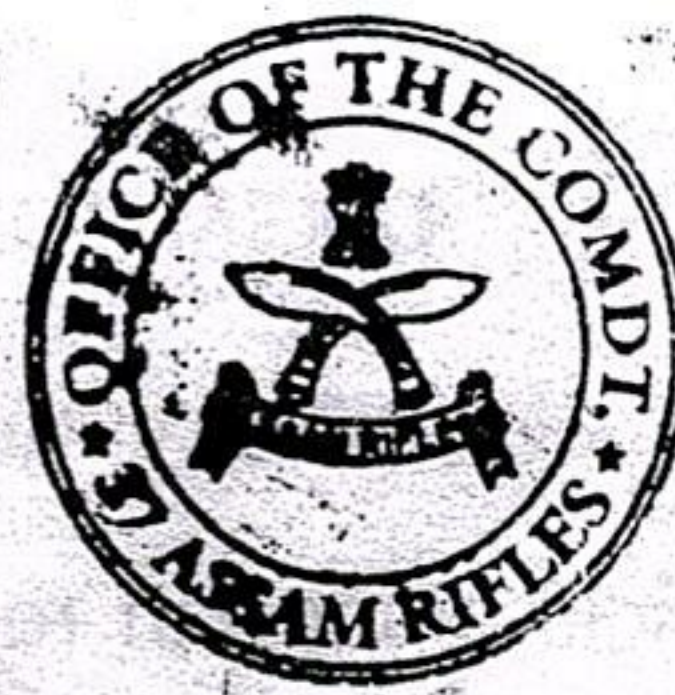
